Director of Volunteers

- * Coordinates yearly T-shirts

Director of Referees and Equipment

- * Secures all referees for applicable events
- * Train referees in our tournament rules
- * Coordinate locations, dates and times with the referees
- * Secures necessary equipment for selected events

- * Secures One Radio, TV and Newspaper sponsor
- * Manages Press Releases
- * Invites media to the tournament, coordinators briefing & closing ceremony
